Official Rules

- I. ENTRY: Louisiana residents are invited to participate in Gordon McKernan Injury Attorneys' Billboard Competition. To enter, participants may visit <u>www.gordongives.com</u> to complete the official registration form with their billboard artwork attached. The Competition begins on Monday, August 12, 2024, and ends at 11:59 p.m. CST on Sunday, September 8, 2024. Entries received outside of this period will not be considered. Each person who submits an entry agrees to be bound by these Official Rules and accepts the decisions of Gordon McKernan Injury Attorneys, which are final and binding. Only one entry will be accepted per eligible person.
- II. **ELIGIBILITY:** Gordon McKernan Injury Attorneys' Billboard Competition is open to the residents of the state of Louisiana. Participants must be aged 18 or older to enter the adult category. Participants under the age of 18 may enter the child category with parental or legal guardian consent.

 - c. All billboards must include the official Gordon McKernan Injury Attorneys logo. Downloadable logo assets are available on the registration page.
 - d. By submitting your billboard design, you grant Gordon McKernan Injury Attorneys the license and right to use, modify, and reproduce the artwork for any promotional purposes and across any medium associated with Gordon McKernan Injury Attorneys or Gordon McKernan. No further compensation shall be provided for such usage.

IV. SELECTION: Gordon McKernan Injury Attorneys will select up to a total of six (6) winners, with up to three (3) winners selected from the adult category and up to three (3) winners selected from the child category.
